The proposed merger would be effective on April 1, 2021. The follow is the merger timeline:

- July 2020: Stakeholder Input: Town Hall Webinar
- Aug. 2020: Integration Planning Completion
- Nov. 2020: CFMA & ICCIFF Final Approval
- Jan.-March 2021: Operational Planning
- April 1, 2021: Merger Go-Live


